RESOLUTION 1-1-2020 – "A RESOLUTION PROVIDING FOR THE ADOPTION OF A BUDGET FOR THE CITY OF LONOKE FOR THE TWELVE (12) MONTHS BEGINNING JANUARY 1, 2020 AND ENDING DECEMBER 31, 2020, APPROPRIATING MONEY FOR EACH ITEM OF EXPENDITURE THEREIN PROVIDED FOR; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES." 2. PERMISSION TO PURCHASE CONCESSION TRAILER FOR THE PARKS DEPT – While the new concession stand is under construction, the parks department is proposing to use a mobile concession trailer. A fully outfitted and permitted trailer was located for sale in Heber Springs for \$5,000. Pictures of the concession trailer were shown to the council members for reference. Once the concession stand is completed, the wagon can be used down at Fields 6-8 for the tournament crowd and for soccer. Koy Butler made the motion to spend us to \$5000 on the trailer. Ryan seconded the motion. Motion carried.
