Mayor Reed opened the meeting to let everyone know that there has been an ordinance prepared to cover a 60-day period of any late fees or disconnection due to Covid-19. Mayor mentioned he does believe that the council has the authority to allow this to happen. Mayor mentioned that in March there were 399 delinquent bills, total of \$2,665.15 late fees. In April there were 337 delinquent bills with a total of \$2,383.03 late fees. The grand total is \$5,048.18 of late fees that would be forgiven. There were comments regarding the bond issue. Ginger Stuart did mention that the city does have to make certain bond covenants. She does not feel that this will be a negative impact. After some discussion, everyone was in favor to allow the forgiveness during this crazy time in our lives.
