- **B.** Telephone System Quotes for City Hall and Police Dept.- Quotes were presented for the council to look for replacing the antiquated Plexar phone systems currently in use at City Hall and at the Police Department. The PD starting experiencing issues with their phone system randomly shutting down about a month ago, and cannot be without a working phone system. Since both systems are the same age, and the computer board cannot be replaced or repaired, it only makes sense to change them both out. (All quotes are pre-tax.)
 - 1. <u>Mitel</u> for \$18,504.50 (PD and City Hall)- Warranty after one (1) year is 15% of purchase price.
 - 2. AT&T- PD for \$8,996.52 and City Hall \$8,712.56- warranty after one (1) year is 15% of purchase price.
 - 3. NSG- PD for \$5175.00 and City Hall \$6,487.50. Includes lifetime warranty at no charge and service calls would be covered by the city's IT service plan. The total is \$12,945.38. Suzette Elmore made a motion to approve the NSG quote. Koy Butler mentioned that he would like to see other quotes since this item is not budgeted. This money will come out of contingent fund. Raymond Hatton seconded the motion. Koy Butler opposed. Motion carried.
