Food trucks operating in Lonoke are subject to Ordinance No. . .

Food Trucks operating on City property, City rights-of-way, and areas of the city zoned as residential must have prior written approval from the Community Development Director. Food trucks operating on **private** property in areas zoned commercial or industrial shall require express written permission from the property owner or designee. Food trucks operating on **property owned by schools** shall require express written permission from the school's governing body or its designee.

Any written permission must be present at the mobile food truck and available for inspection upon request.

Concessions, operations and agreements managed by the Lonoke Parks and Recreation department are not subject to the above regulations.

All food trucks conducting business in the City of Lonoke must have as part of the approval process:

- 1. Complete and signed Mobile Vendor Application.
- 2. Food Service Establishment Permit from Arkansas Department of Health.
- 3. **A current fire inspection** call City Hall or email Fire Chief Justin Whittenburg at fire@cityoflonoke.com to schedule an inspection time. This is the first step in the permitting process;
- 4. A current health inspection;
- 5. A valid driver's license;
- 6. A current business license;
- 7. **A current Lonoke Advertising and Promotions license** available at no cost at the City Administration's Office at 107 W. 2nd St., Lonoke, AR 72068 (501) 676-4300.
- 8. A picture of truck.

Rules for Food Trucks:

Each truck may only operate at the specific location listed on the written approval. No dining area is permitted without prior approval. Each truck must offer a waste container for public use. Truck operators must remove all trash at their expense and shall not use dumpsters of existing businesses without permission of those businesses. No food truck shall make or cause to be made any unreasonable or excessive noise in violation of City ordinances. Trucks cannot be parked on the street overnight unless they are part of an ongoing event. Unless otherwise specified, permits are good for the current calendar year.
